There was no Executive Session held.


F. Adjournment

Strategic Plan Background

- **July 13, 2004- Strategic Planning Steering Committee was appointed by Town Council**

- The committee completed SWOT analysis of 11 different citizen and business groups and a citizen survey was conducted.
- The SWOT analysis and citizen survey were used to identify problem areas, select the most pertinent issues, and devise an action plan.

- **July 12, 2005- Town Council approved the Strategic Plan**

- The strategic plan contained 5 goals with desired outcomes in the areas of transportation, business development, budgeting, governmental best practices.

- This plan included an action plan for implementation and served as the basis of a 10 year long-term strategic plan.

- **Between 2006-2008- The Implementation Plan was executed**

- A subcommittee of residents, business representatives, and elected officials were appointed for each goal to create deliverables.

Strategic Plan Background Cont.

- January 2008- Town Council approved the 10 year Town of Farmington Strategic Plan
 - This plan included Town Council/Town Manager goals.
 - The goals are established by the Town Council and provide direction to the Town Manager and her staff.
 - The Strategic Plan is reviewed and updated by the Town Council every 2 years.
 - The Strategic Plan is the work plan for all municipal operations.
 - The budget is directly tied to the Strategic Plan's goals and objectives.

Strategic Plan Background Cont.

- **February 11, 2014- Strategic Planning Committee appointed by the Town Council**
 - The Committee completed a second citizen survey that was used to update the 2005 Town of Farmington Strategic Plan.
- **November 5, 2014- Strategic Planning Report was approved by Town Council.**
 - Goal # 6: Recreation was created

Survey Highlights

Overall, both survey results were extremely positive.

- **Quality of Life**
 - 2005- 93% rated as excellent/good
 - 2014- 96% rated as excellent/good
- **Town Government Rating**
 - At least 75% of residents rate government services as excellent or good.
 - The Police Department, Fire Department, and Library were listed as the top rated services, but all Town services were rated very positively.
- **Educational Rating**
 - Farmington's Public Schools are considered to be one of the best features of the Town.
 - 81% of residents rate Farmington Public Schools as excellent or good.

Survey Highlights Cont.

- **Issues**
 - The most important issues identified in both surveys are traffic congestion, taxes, and issues various topics surrounding the school system.
