A. Call to Order

- C. Presentations and Recognitions

presentation to the 7th graders called East Asia Day. This presentation brings together peers of many different backgrounds of East Asian Culture, ranging from Chinese, Japanese, Vietnamese, Korean, and Laotian cultures to introduce the students to different facets of each culture, and

WHEREAS, Caterina Wang's program allows the students to interact with role models, as well as ask questions and show their curiosity for topics that they can then conduct self-directed research projects on, and

WHEREAS, Caterina Wang has demonstrated superb leadership skills as President of the Asian American Club, Vice-President of the National Honor Society, Editor-in-Chief of the Farmington High School Yearbook, and serving on the Board of Directors for the Girl Scouts of Connecticut.

I. Report of the Committees

1. UCONN Health Committee

The Chair reported the Committee had met on June 8, 2018, and the UCONN Health Center representatives had given a report on various facts regarding the Health Center. They reported there were 5500 employees, over one million people are in and out of the complex per year and there are 27 towns in Connecticut out of 169 larger than the UCONN Health Center. They encouraged the Town to pass the word that the Health Center is here in Farmington with many different services.

2. Land Acquisition Committee

Ms. Boye-Williams reported the Committee had completed the update of the list and map, both were on the Town website, the Town closed on 440 and 8658 Plainville Avenue on May 18, 2018 and the next meeting was scheduled for June 14th at 5:00 p.m. in the Town Hall.

3. Green Efforts Committee

Ms. Boye-Williams reported the Committee had met the previous week, the next meeting was scheduled for August 7, 2018 at 6:30 p.m. in Town Hall Council Chambers, they were in the process of exploring ways to reduce energy usage and waste in Town including alternatives for trash removal and encouraging composting and exploring the Sustainable CT certification program to follow the task items but not necessarily obtain the certificate.

J. Report of the Council Chair and Liaisons

1 Chair

The Chair thanked everyone that had participated in the Memorial Day Parades and especially Paul Krause and the VFW for their support and planning. She felt both parades had been a big success.

2. Board of Education Liaison

Ms. Kintner reported the BOE had had a joint meeting with the Council on May 15, 2018 at which the two ad hoc committees had been established to address the needs of the Farmington High School, there had been a reception for Bill Silva, Principal of Farmington High School in honor of his award as High School Principal of the Year from the Connecticut School Association, there were summer professional development projects being planned, the renewal of the cafeteria contract with Chartwells was approved, the Noah Wallace Fund had approved three projects for next year totaling \$34,000 and at their June 4, 2018 meeting they had given out several student recognition awards.

3. Chamber of Commerce

Mr. Thomas reported the Chamber would be holding a Business After Hours meeting at the Atria on 111 Scott Swamp Road at 5:30 p.m., a Mondays in July which was a female golf clinic at Tunxis Golf Course and on August 17, 2018 the Chamber was holding their annual golf tournament at Farmington Woods for the benefit of the East Farms Fire Department.

4. Economic Development Commission Liaison

Mr. Giannaros reported the Commission was hosting their first Business Resource Breakfast the next day at Power Hawk Inc. at 7:30 a.m. on Route 6. The title of this breakfast was Energy Efficient Solutions to Save You Money. The Business Resource Breakfast series was the idea of Brian F.X. Connolly and supported by everyone on the Commission.

7. Human Relations Commission

Ms. Kintner reported the Commission had met on May 23, 2018, Nancy Parent informed the group she had applied for a grant from the AARP to improve accessibility at the Senior and Community Center and for bike racks across Town and there was discussion regarding the 2011 US Access Board Guidelines which are more inclusive than ADA guidelines.

8. Library Board

9. Town Plan and Zoning Liaison

Mr. Charette reported the construction on the corner of Bridgewater Rd and Route 4 had started for the 120 units of assisted living and the 32 units of elderly housing, the site work at 5 corners had started, Loehmann's Plaza had had an informal meeting in February with the TPZ and expected to have a formal proposal in the fall of 2018 and St. Patrick's Church planned on ground breaking in 2019.

MDC Lawsuit

The Manager reported on the class action lawsuit against the MDC brought by the residents in the non-member towns served by MDC. She estimated approximately 9,000 businesses, residents and town facilities were affected by the law suit. She explained currently there was no action necessary by the Town.

Live Streaming

The Manager reported that beginning July 10, 2018 the meetings would be broadcast live on Nutmeg TV as well as the regular schedule of viewing.

Farmington Center Committee

The Manager discussed with the Council the need to establish the Committee as soon as possible, the phased charge of the Committee and possible makeup of the Committee. It was the consensus of the Council to have the Manager move forward with the Committee for the July 10, 2018 Regular Meeting.
