**A. Call to Order.**

The Chair called the meeting to order at 5:30 p.m.

**B. Public Comment.**

Tim Kelly, 62 Westview Terrace, shared his initial reactions of the survey with the committee. He suggested mailing the survey to residents to encourage thoughtful responses and to get an understanding of how residents trust the process. He believes questions #1 and #2 are not required, and suggested adding demographics including home owner, working/retired and more information regarding type of employment.

**C. Minutes**

**1) To approve the attached September 12, 2018 minutes.**

C.J. Thomas proposed adding that the committee agreed not to include the previous referendum vote in the survey to the paragraph that starts with "Kathy Greider, Superintendent of Schools..." on the second page.

Beth Kintner also suggested changing "all residents" to "both registered/non registered residents," as only a sample of the larger population will be surveyed.

Upon a motion made and seconded (Thomas/McInnis) it was VOTED: to approve the September 12, 2018 minutes as amended.

Ellen Siuta abstained, as she was not at the last meeting.

**D. New Business.**

**1) Update from FHS Facility and Financial Ad Hoc Committee.**

Sharon Mazzochi, FHS Facility & Financial Ad Hoc Committee member, reported that the FHS Facility & Financial committee has met three times. She explained that Joe Swetcky, Director of Finance presented twice on the projected debt forecast, but the committee will use the survey results to finalize their findings.

Kat Krajewski informed the committee that the FHS Facility & Financial committee also had a presentation on the FHS facility. All presentations are posted on the [Town of Farmington website](#). The next meeting is scheduled for October 16, 2018 at 7:00 PM in the FHS Library.

**2) To review the draft survey questions.**

Feedback from Bruce Charette and Paul Cianci (members of the FHS Facility and Financial Ad Hoc Committee) were distributed for the committee to review and consider as they reviewed the draft survey questions. These emails are attached to these minutes as Attachment A. Sharon Mazzochi added that she believes the questions are clear and concise.

The committee reviewed Draft I of the survey. A copy of this draft is attached to these minutes as Attachment B.

Below is a summary of the survey discussion:

- Question #3- The scale was changed to 1- Very Poor and 10- Very Good
- Question #3- Change wording to "overall impression of the quality of FPS"
- Add a question similar to #3 regarding Town services
- Paragraph before Question #4- Remove the sentence prior to ...A Committee has been charged.
- Remove Question #5
- Question #6- change to "Overall, and in general, how important is it to you that some changes are made to FHS?"
- Question #7-remove "upgrades/modernization", replace with "facility changes"
- Question #7- It was confirmed that this is an open ended question. Requested the consultant to add community shelter use to response 05, add temperature control, add gymnasium

Minutes are considered "DRAFT" until approved by committee at next meeting.

- Question #15- Add traffic flow
- Questions #16-17- There was general discussion regarding the wording of these questions. Jerry Lindsley, CRPP, will review and revise for the next draft.
- Question #18- Remove "in any new design"
- Questions #18-22- There was general discussion regarding the wording, particularly of question #20. Jerry will review and revise for the next draft. There was also discussion of adding the same question but regarding the understanding of the needs.
- Question #21- Replace "modern" with "updated"
- Question #23- The committee had discussion regarding the word "only", as well as adding "mandated" to requirements. The committee also wanted to add "required updates" to each of the responses. Jerry will review and revise for the next draft.
- Questions #24-27- The committee decided to skip these questions and safe for next time, as they deal with finances.
- Question #28- Remove the word "issues" from the question. Add FPS app, Facebook pages like "Talk of Farmington" to the responses. It was discussed to provide the researchers with information regarding opponents/proponents, as they may be identified by name.
- Question #30- Remove "modernization"
- Questions #24-41- There was general discussion regarding these questions and what should be included. Remove questions #37 and 41. Jerry will review and revise for the next draft.
- It was suggested to add a question asking the respondent to recall what the cost of the previous high school project was.
- Questions #41-52- remove questions #49-50
- Question #52- revise to be more representative of the total family income in Farmington.

**3) To review the attached survey project timeline.**

The committee reviewed the survey project timeline, noting that CRPP needs the committee's approval by 9:00 a.m. on October 12, 2018.

The committee's next meeting will be on Thursday, October 4, 2018 at 6:00 p.m. (location TBD). The committee also saved October 201, 2018 at 6:00 p.m. as a potential meeting date prior to the deadline.

Beth,

First, a quick thanks to you and your committee for all the hard work put in so far. Second, as I mentioned on the way out of last night's meeting, I did want to send an email with some questions/concerns regarding the draft survey questions sent out earlier this week. I've summarized them in a list below:

- Generally speaking, I am concerned that the survey as written is too long. If somebody ends the survey before it is completed, will the data already collected be included in our results? Or, will all data be voided unless the survey is completed? Also, the questions identifying how the person felt about the last project are not until the end. In my opinion, this information is critical to simulate a realistic referendum turnout.
- Along the same lines, most of the questions pertaining to cost are not presented until the latter part of the survey. My concerns here are twofold:
  - If data from incomplete surveys is part of our final results, we may have accumulated data from people who haven't even had cost presented to them as a variable.
  - Even if data from incomplete surveys is eliminated, I still have concerns that we are asking questions without any kind of budgetary numbers attached to them. For example, in questions 8 through 17, I think it is really hard for people to answer the questions accurately without understanding a cost impact.
- Question 3 – Usually, for a scale of 1 to 10, I intuitively think of 10 as the best and 1 as the worst, which caused me have to double think my answer. I'd be curious as to how many others think of this. Certainly don't change this on my accord, I just wanted to bring it to your attention in case others had to double think their answers as well.
- Is question number 7 open ended? Or will people be given a menu of examples to pick from?
  - If the former, what if somebody says something like "new gym" or "better AC" or something not on the list. How will these be keyed in by the surveyor on the phone?

- If the latter, I have concerns that people will simply say “yes” to many or all of the items without understanding all the variables (most notably, the cost impact, analogous to my concern above).
- I believe that some of the wording in some questions is not neutral, and will sway people away from certain answers.
  - Example: Question 23 – the word “only” next to the third option may subliminally push people away from selecting this option in my opinion.
- Questions 24 through 26: My concern here is that most people don’t understand what “\$X annually over 20 years for the average Farmington property owner” means in property tax increases for themselves and/or the mill rate when it’s all said and done.
  - As an example, when I sampled Question 24 with my wife, she gave me a funny look, and said, “Sure.” As worded, that didn’t seem like an exorbitant amount of money to her. When I followed up with her in regards to what that meant for our personal tax increases, and more importantly, the mill rate increases for the town as a whole, she responded with an emphatic “No.” If my wife, who has a post-graduate level degree and a spouse talking to her about local issues on almost a daily basis found this wording confusing, my fear is that others will find it confusing as well.
  - Personally, I think the best way to see what people believe we can afford would be to put the total municipal project cost. That being said, I can appreciate that fact that \$100 million, \$60 million, \$40 million, etc. may seem like large, abstract numbers to many people. Therefore, I would suggest following each construction budget range with a % increase to the mill rate as a result. I believe that people generally have a good feel for what they pay in taxes, and therefore, can appreciate what each project size would mean in terms of a % increase to their own taxes.

I realize there is a lot here. If it is easier to discuss over a cup of coffee, let me know and I’d be happy to meet up sometime.
