## F. <u>DIRECTOR OF PUBLIC WORKS/ WPCF PROJECT ENGINEER'S REPORT</u>

Current report dated July 2015 – Alex Kaminski, WPCF Asst. Supt. briefed the Authority on the following projects:

## **Public Sewer Construction**

- **1. Manhole Raising Bid-** Desell Construction to commence construction in July.
- 2. State Project 51-260- Farmington Avenue, Garden Street to Mountain Spring Road- Construction began in the area of Garden Street and has proceeded through the Route 10 intersection and is continuing easterly.
- 3. Maple Street/Garden Street Sewer- Installation of the new sewer line has begun starting on Garden Street in the vicinity of Maiden Lane and is continuing south towards Maple Street.
- **4. Manhole Lining-** Work to epoxy-line 10 manholes to eliminate corrosion concerns should commence in July. Contract paperwork being finalized by contractor and Town Staff.

## Sewer Pump Station Construction and Repairs

- 1. Stanley Pump Station- The emergency back-up float system was replaced with a conductivity rod system. The system was integrated into the pump station control and SCADA systems in June. Initial operation of the level controller has proven reliable.
- 2. Patrick Flood Pump Station- Control system upgrades are in progress.
- **3. Batterson Park Pump Station-** The Town will be receiving a review set of plans for the pump station upgrade from Wright Pierce by mid-July.

#### Plant Upgrade-

 Changes to the specifications were submitted to DEEP to satisfy CWF requirements. It is anticipated that approval to bid the WPCF Comprehensive Upgrade Project will be received by mid-July.

7 sewer permits were issued during May 2015

1. WPCF upgrade project timeline for advertising, pre-bid meeting, and bid opening was presented to the Authority. Chairman Foote questioned the bid date and recommended that it would be better if it was Sunday or Tuesday. Also recommends that bidding time be 6 weeks with an extension of 1 week for addendums.
