## F. DIRECTOR OF PUBLIC WORKS/ WPCF PROJECT ENGINEER'S REPORT

Current report dated November 2015 – Alex Kaminski, WPCF Asst. Supt. briefed the Authority on the following projects:

## **Private Sewer Construction**

1. None

## **Public Sewer Construction**

- Manhole Lining- Work to seal and structurally rehabilitate the manhole added to the project has been completed. This manhole was estimated to have over 10 gallons per minute of infiltration and serious structural defects.
- 2. State Project 51-260- Farmington Avenue, Garden Street to Mountain Spring Road- Mainline sewer installation has been completed. The replacement of several sanitary sewer laterals, video inspection of the 8" sewer main, and restoration tasks remain.
- **3. Coppermine Road #33-27-** The sanitary sewer mainline has been installed and approved.

## FOG Program

1. Staff submitted an article for the Town Newsletter to raise awareness about FOG and improper disposal of wipes and non-flushables.

# **Sewer Pump Station Construction and Repairs**

1. Westfarms Pump Station- The radiator for the emergency generator was replaced because of leaks and corrosion. Parts totaled approximately \$5,000 and labor was performed by WPCF staff.

#### **WPCF Construction/Repairs**

 The chlorine contact basin mixer failed and will be sent out for machine repair. WPCF staff took alternate measures to provide adequate mixing in the chamber until the end of the disinfection season.
