A. Call to Order.

The meeting was called to order at 4:03 P.M.

B. Approval of the Minutes.

1. Approval of the minutes from the September 10, 2020 FHS Building Committee Communications Subcommittee meeting.

Upon a motion made and seconded (Guerrera/Siuta) it was unanimously VOTED: to approve the minutes from the September 10, 2020 meeting.

C. Subcommittee Updates.

1. Video Tour and Other Videos.
