# Unionville Historic District and Properties Commission November 12, 2020 DRAFT: Minutes

Meeting called to order at 7:02 pm by Lisa Johnson.

## **Approval of Minutes:**

October 22, 2020 minutes – as amended with two corrections (Horton/Martin/all) (M/S/A)

### Public Hearing for Certificate of Appropriateness for 48 Cottage St.

The hearing opened at approximately 7:05pm.

Shannon Rutherford read the legal notice into the record.

Bob Hoffman corrected the legal owners of the property – Robert Hoffman and Margaret Sweet-Hoffman. Bob Hoffman then presented the application for the installation of 3 ft x 5 ft walkway to be located at the bottom of the homes' front stairs and will connect to the driveway. The walkway shall be constructed out of cobblestones. Photos were provided showing the location of the walkway. Specification sheets were provided showing the cobblestone. Cobblestones were selected for their durability and heft, given the water runoff in this location.

The Commission members provided comments regarding the uneven surface that cobblestones can present; however, noted that there was no objection to their use in this instance. It was noted that the age and appearance of the home would be compatible with differing types of block for the walkway and that the cobblestones were certainly compatible. (During the review of comments from the Commission, we found that Bob Hoffman was no longer on the call / zoom meeting. Matt Ross was able to reach Bob and learned that Bob's internet connection had failed and he was not able to restore the connection before the end of the meeting.)

No comments were received from the public.

Lisa Johnson closed the hearing at approximately 7:20pm.

Barbara Marsh made a motion to approve as presented, noting that the applicant can choose to modify the type of block for the walkway and the modification would be reviewed via email by the Commission members, Sherry Horton seconded, all approved unanimously.
