<u>Goal 3:</u> Manage actions taken to improve traffic problems including meeting with the State of Connecticut Department of Transportation on quarterly basis. Report on the following projects to the Town Council on a quarterly basis.

<u>Goal 4:</u> To continue to evaluate the potential and location of an additional river crossing with the State of Connecticut Department of Transportation to alleviate traffic in the Town Centers.

Route 10 Sidewalk Replacement Project:

The Town of Farmington held a pre-bid meeting on August 17, 2021, and no firms attended. It is our assumption that the lack of interest was due to the time of year in which the project was advertised. Also, we have been finding that many construction companies and other types of business are extremely busy and at full capacity. We have also been finding that in general the supply chain is slow. The Town intends to re-issue the bid late fall/early winter to proceed with the project during the next construction season (Spring 2022).

Brickyard Road Pavement Rehabilitation Project Phase 2:

The second phase of Brickyard Road Pavement Rehabilitation design was approved, and we received our Commitment to Fund Letter from the CT DOT. We will be advertising the project for bidding early winter 2021/2022. Phase 2 of the project is from Wildwood to the Avon Town Line. The project was designed in house and construction is funded by the CT DOT/CRCOG through the LOTCIP Program.

• Project # L51-004 Two Mile Road/South Road/Colt Highway Roundabout: The design is 90% complete and we are addressing review comments from the CT DOT and expect the final plans to be submitted back to the CT DOT by mid-October 2021. The expectation is to advertise for bidding in early winter 2022 for spring construction. The Engineering Division worked with Metro Realty for a public/private partnership to pay for the design of the roundabout and submit it to CT DOT for approval for construction. The reason for the partnership is to obtain

overall improvements to the already unsatisfactory operation of the intersection and the new project exasperates the condition. Construction is 100% funded by CRCOG through the LOTCIP program.

Bridge Crossing at Monteith Drive

The Engineering Division was notified that we received a \$150,000 grant for a bridge study for this location. The Town is responsible for 10% or \$15,000 of the study. This study is the first step towards future funding. The scope of the study was reviewed and approved by CRCOG, CT DOT and the Town Engineering Division. The study will take up to 6 months to complete and will start in October 2021.

State Project #51-0272 Unionville Bridge Rehabilitation Project:

The CT DOT started this project in March of 2021. During construction they discovered that the structural steel for the sidewalk support and railings were in worse condition than originally designed for, needed to be re-designed. Due to the majority of the structural steel repairs on the truss, the CT DOT has concluded that a full painting of the bridge is warranted, which is better than the original spot repairs that were proposed for the structure. A new schedule is anticipated to be received later in October 2021.

Provide needed support to ensure that the Farmington High School Building Committee moves forward and receive the appropriate staffing support to complete objectives. Provide quarterly reports to the Town Council.

The Farmington High School Building Committee (FHSBC) hit the ground running after a successful referendum on June 3, 2021. At their next scheduled meeting on June 30, 2021, the FHSBC issued a notice to proceed to TSKP Studio to complete final plans, working drawings and specifications, and bid documents. This allows the architect to move forward with enhanced schematic design and maintain the timeline set forth before the referendum.

Since the referendum, the FHSBC has been focused on rounding out the professional partners to join our owner's representative (CSG) and architect (TSKP Studio) on this project and developing a communications plan to keep residents informed and updated on the progress. Below are highlights from actions taken by the FHSBC since July 1, 2021, to support those efforts.

Professional Partners Update:

- Authorized a contract with Construction Solutions Group (CSG) for owner's representative services from design development to construction close out.
- The FHSBC voted to include design consultants for various elements of the design. Some of these consultants were included in the original budget estimate (environmental design and universal design), and some are additional design consultants that were added to the architect's scope of services. The design consultants include:
 - Atlas Technical Consultants Company, Environmental Design (approved August 25, 2021)

- o Crabtree-McGrath, Food Design (approved August 25, 2021)
- Institute for Human Centered Design, Universal Design (Approved September 8, 2021)
- Theater Design Inc., Theater Design (approved September 8, 2021)
- The FHSBC Issued an RFQ for Construction Management Services on July 29,
 2021. The committee received 10 proposals in response to the RFQ.
- After evaluating each of the proposals, on September 8, 2021, the FHSBC voted to shortlist 4 firms for interviews and issued an RFP/fee proposal to those shortlisted firms. The shortlisted firms include:
 - o D'Amato + Downes
 - Gilbane
 - o **O&G**
 - o Turner
- The FHSBC conducted interviews on September 22, 2021, and selected O&G
 as the finalist for construction management services contingent on a due
 diligence review of references and the fee proposal. The Professional
 Partnership Committee will begin contract negotiations with O&G.

Communications Update:

- Approved a sustained communications proposal with Tall Timbers Marketing to continue our communication efforts through the completion of construction. The communications plan includes:
 - Create/distribute a newsletter to be mailed to all residents every 6 months
 - Hold in person/zoom public information meetings regarding status updates on the project
 - o Website and social media updates, including video updates
 - o Press releases/media support

Other:

• The FHS Building Committee members took a tour of Guilford High School on August 13, 2021. Guilford High School was design by TSKP Studio and has many of the same design elements are in the FHS Building project. Building Committee members found it beneficial to see a design by TSKP in person.

The FHSBC is excited to move forward with the design development and construction phases of the project. With a construction manager on board, they will begin planning the logistics of construction and solidifying a construction timeline. The architects will continue to work to complete the design documents as we prepare for an anticipated start of construction in late summer/early fall 2022. Individual sub-committees will meet regularly throughout the month to work on their respective goals, and we plan on expanding the Taskforce to include more volunteers. The Taskforce took a hiatus for July. They met on June 21, 2021, August 16, 2021, and September 29, 2021.

Progress to Date:

1. Community Conversation Goal

 The Community Conversations took a break during the summer. The group plans to reconvene in the fall and continue working with RE-CENTER to create an outline for topics for the next year's Community Conversations.

2. Community Policing Goal

• The sub-committee has discussed creating programming that included basketball games between officers and students with "For the Talented" basketball group. They would also like to see more police officer interactions with summer camps and a Police Outreach night for IAR students - "What to expect during a traffic stop" etc. During the summer, Officer Vincent visited summer camps and officers gave gator rides with children at camps and performed drone demos. Officer Martin was at Hurlock Basketball Camp and other summer camps. The Farmington Police have scheduled a free seminar for businesses on October 20, 2021 at Farmington Gardens. The seminar is titled "Enhancing the Customer Experience by Preventing Implicit Bias." Officers will also work with the schools to ensure that parents are notified of any interactions (good, bad, or neutral) with a police officer at school.

The Green Efforts Committee has redirected its energy and focus from applying to Sustainable CT to focus on action items. The Committees is working on an anti-idling project to post signs in schools loading and unloading zones. The Simple Recycling program has diverted 7000lbs of waste to recycling since May 2021. The Committee is working on developing articles for Town newsletters to share information about Green Committee projects and share sustainable ideas with the community. The Committee is preparing for 2022 Clean Up Day. Shannon Rutherford is now the staff liaison for the Green Efforts Committee.

Establish a comprehensive ten-year facilities improvement plan for Tunxis Mead Park. The Plan shall establish what major improvement projects should be undertaken over the next 10 years with associated project schedules and costs. Provide Quarterly Reports to the Town Council.

The town's Youth Services have created a sub-committee to help develop a plan for the skateboard park renovations in the current capital budget. The first meeting of this committee will be October 5th and the group consists of several students and families who have an interest, several alumni who have been active in the skate park as well as youth service staff. To prepare for the meeting, we have surveyed multiple towns regarding their skate part operations, cost and recommendations. We have developed a lengthy list of recommendations, potential elements, and design ideas. We have visited several of our neighboring towns to inspect and evaluate their parks. One of the first goals is to discuss the elements of the park and start a cost analysis. It is anticipated once our initial plan is developed to hold a public forum meeting at the skate park to solicit further suggestions and ideas.

HEATSafe Community Designation

The Town of Farmington recently met the renewal requirements for the HEARTSafe Community designation for another 3 years set by the Office of Emergency Medical Services and the American Heart Association. A HEARTSafe community is one that has documented the "Chain of Survival" links to address cardiac emergencies for its citizens. These links include early access to emergency care, early CPR, early defibrillation, and early advanced care. Through the dedicated work of our Firefighter/EMTs, businesses and citizens we have maintained our designation and continue to be HEARTSafe!

Cardiovascular disease is the leading cause of death in the nation and Connecticut. Approximately 4,500 Connecticut residents die each year due to sudden cardiac arrest. Most of these deaths occur out of the hospital, away from advanced medical assistance and usually happen in the presence of a family member or friend.

The Town of Farmington Fire Department provides quarterly Community CPR to educate the public on these life-saving techniques. This course teaches CPR and relief of choking in adults, children and infants. Use of an AED (Automated External Defibrillator) is also included in the training, and participants receive a student manual for ongoing reference. Community CPR is designed for members of the general public who would like to learn basic CPR, including families with children or elderly relatives,

The Town of Farmington Fire Department is dedicated to providing for the safety and welfare of the community through the preservation of life, property, and the environment, by maintaining a constant state of readiness through fire fighter training and public education.

community groups, and those who do not need a course completion card. This course is at no cost as we know how important these critical skills are in an emergency. Members of the public can register for the classes through the Town of Farmington Fire Department website.

The Town of Farmington Fire Department trained 310 residents on CPR from 2019 to 2021. There are also 65 AEDs throughout the community in both Town buildings and private businesses providing added support in maintaining a HEARTSafe Community. This designation is a testament to our commitment to enhance the probability of survival after a significant cardiac event.
