A. Call to Order

- 1) Chair Report
 - a. Walk Against Hate would like to do something in a more organized fashion in the future years.
 - b. Advocacy the building committee hired the Institute of Universal Design on the building of the new high school. Their purpose is to consult throughout the project to ensure the concept of universal design is adhered to.

- c. The Village Center no response to RFP that was put out over the summer. The Town will reissue an RFP in hope the project will start in the spring of 2022
- d. Infrastructure Bill on hold. Another bill having to do with pedestrian rights of way, accessibility guidelines Tulin reached out to Senator Blumenthal and Congresswoman Hayes regarding the bill.
- e. Parent & Tulin attended a statewide forum of Human Rights commissions that included 8 CT towns with commissions. There is a private Facebook group with people from the forum sharing their missions.
- f. October 12 Town Council Meetings Myra Clark Segul was introduced by Tulin. Town Council was very receptive to the presentation.
- g. Upcoming November 22nd meeting should members of the citizens coalition for equal access be invited to speak or present?

2) Department Of Social Services

- a. Parent was appointed by Kathy Blonski as the new ADA coordinator for the Town.
- b. Statewide group summary
- c. 3 Upcoming events Veteran's Thank you Luncheon, Senior Holiday Gathering, and starting Holiday Giving Program.
- d. Annual Report Miles driven 41,960 with new van, which is a 44% increase.

 - e. Drat for RFP inclusion specialists was written. Will partner with other towns and Task Force will work as the consultant to hire someone to help with interviews.
