The subject property consists of two parcels of land. Both parcels are within the R-12, Residential Zone. The parcels have a combined land area of 1.46 acres and a total of two single-family homes located on the Farmington River. The individual parcels are described as follows:

1535 Farmington Avenue, Farmington, CT

The subject property consists of a roughly rectangular parcel of land having 114.29 feet of frontage along the southwesterly side of Farmington Avenue, a.k.a. Route 4. The site, zoned R-12 – Residential, has a land area of 16,320 square feet or .37 of an acre. The site slopes below street grade to the Farmington River and has 109 feet of frontage along the northeast banks of the Farmington River.

At the present time, the site is improved with a two-story plus walk-out basement, contemporary-style single-family home, built 2003, composed of 2,622 square feet of gross living area.

1541 Farmington Avenue, Farmington, CT

The subject property consists of an elongated, roughly rectangular parcel of land having 432.78 feet of frontage along the southwesterly side of Route 4. The site, zoned R-12 – Residential, has a land area of 47,440 square feet or 1.09 acres. The site slopes below street grade to the Farmington River and has 345 feet of frontage along the northeast banks of the Farmington River.

At the present time, the site is improved with a one-story plus walk-out basement, ranch style single-family home, built in 1930 and 1955, composed of 906 square feet of gross living area.

Town staff is recommending that the Town purchase these properties for the future Third Bridge Project. To complete this project these parcels or a portion of these parcels need to be acquired. It is a benefit to acquire the parcels through this process now instead of the State taking the properties through the eminent domain process which could significantly delay the project. It is also a benefit to acquire these properties now so that they can be used as a staging area through construction. Lastly,

these properties are riverfront, therefore, the remaining portions could be used for passive recreation after construction is complete.

Town staff has been working with the homeowners and they are in agreement that this is the preferred method of acquiring the properties.

The procedure for open space acquisition approval for this property includes the following steps:

- 1. Setting public hearing for the October 11, 2022 Council meeting at the September 13, 2022 Council meeting **Complete**
- 2. Hold public hearing on October 11, 2022. Complete
- 3. Make 8-24 referral to TPZ at the October 11, 2022 meeting Complete
- 4. Receive TPZ 8-24 report at the November 15, 2022 meeting Complete
- 5. Vote on acquisition authorization at the November 15, 2022 meeting.

That the attached resolution, Items 1 and 2, be forwarded to a Special Town Meeting to be held on November 28, 2022, with a recommendation that it be approved.

NOTE:

The attached resolution contains the items to be considered at a Special Town Meeting to be held on November 28, 2022. By Charter, the Town Council forwards this resolution to a Special Town Meeting with a recommendation that the resolution be approved. The Special Town Meeting will be held at 7:00 PM in the new FHS Auditorium.

Item 1. Appropriates an additional \$9,700,000 to increase the total appropriation to \$145,300,000 for the costs related to the design, construction, furnishing and equipping of a new high school on the grounds of the existing high school, the costs related to demolition of the existing high school except for the 1928 building and the 900 Wing of the existing high school, for costs related to the renovation of the 900 Wing to house locker rooms and the Farmington Public Schools Central Offices and authorizes the same amount less any state grants received in borrowing to finance the project.

Item 2. Lists the times and voting places for the December 8, 2022, referendum and the wording to appear on the ballot for the question. Item 2 also authorizes the Town Clerk to prepare an explanatory text, subject to the Town Attorney's approval for the resolution.

The Town Council should carefully review the resolution, especially subsections 1 (a) and 1(c) (a) to make sure that they reflect the Town Council's intent regarding the project.

Staff will be available at the Town Council meeting to answer questions regarding the resolution.

RESOLUTIONS FOR TOWN COUNCIL (Special Town Meeting and Referendum)

Item 1.

RESOLVED, that a Special Town Meeting be held on Monday, November 28, 2022, to consider and act upon the following resolution which the Town Council recommends be approved:

RESOLUTION AMENDING THE RESOLUTION ENTITLED "\$135,600,000 APPROPRIATION AND BORROWING AUTHORIZATION FOR DESIGN AND CONSTRUCTION OF A NEW HIGH SCHOOL ON THE GROUNDS OF THE EXISTING HIGH SCHOOL CAMPUS, DEMOLITION OF SUBSTANTIALLY ALL OF THE EXISTING FARMINGTON HIGH SCHOOL OTHER THAN THE 900 WING AND THE 1928 BUILDING, AND RENOVATION AND IMPROVEMENTS TO THE 900 WING" TO INCREASE THE APPROPRIATION AND BORROWING AUTHORIZATION TO \$145,300,000

WHEREAS, on June 3, 2021, the voters of the Town approved a resolution entitled "\$135,600,000 APPROPRIATION AND BORROWING AUTHORIZATION FOR DESIGN AND CONSTRUCTION OF A NEW HIGH SCHOOL ON THE GROUNDS OF THE EXISTING HIGH SCHOOL CAMPUS, DEMOLITION OF SUBSTANTIALLY ALL OF THE EXISTING FARMINGTON HIGH SCHOOL OTHER THAN THE 900 WING AND THE 1928 BUILDING, AND RENOVATION AND IMPROVEMENTS TO THE 900 WING" (the "Original Resolution") for the design, construction, furnishing and equipping of a new high school (the "Project"); and

WHEREAS, after opening bid packages for the Project, the Town has determined it will need an additional \$9,700,000 for costs of the Project as a result of effects from the current inflationary environment, supply chain shortages, and other economic factors; and

WHEREAS, Public Act 22-118, enacted and signed by the Governor on May 7, 2022, increased the Town's grant reimbursement rate to 30.00% (for approximately an additional \$14,400,000 in reimbursement grants from the State of Connecticut for the Project, as amended); and

WHEREAS, in order to account for the additional costs of the Project, the Original Resolution will need to be amended to increase the appropriation and borrowing authorization.

RESOLVED,

(a) The Original Resolution adopted June 3, 2021 by the voters of the Town, entitled "\$135,600,000 APPROPRIATION AND BORROWING AUTHORIZATION FOR DESIGN AND CONSTRUCTION OF A NEW HIGH SCHOOL ON THE GROUNDS OF THE EXISTING HIGH SCHOOL CAMPUS, DEMOLITION OF SUBSTANTIALLY ALL OF THE EXISTING FARMINGTON HIGH SCHOOL OTHER THAN THE 900 WING AND THE 1928 BUILDING, AND RENOVATION AND IMPROVEMENTS TO THE 900 WING" (the "Original Resolution"), which is hereby ratified, confirmed and adopted, is amended by increasing the appropriation and bond authorization by \$9,700,000 to a total of \$145,300,000.

- (b) The title of the Original Resolution is hereby replaced in its entirety by the following:
- \$145,300,000 APPROPRIATION AND BORROWING AUTHORIZATION FOR DESIGN AND CONSTRUCTION OF A NEW HIGH SCHOOL ON THE GROUNDS OF THE EXISTING HIGH SCHOOL CAMPUS, DEMOLITION OF SUBSTANTIALLY ALL OF THE EXISTING FARMINGTON HIGH SCHOOL OTHER THAN THE 900 WING AND THE 1928 BUILDING, AND RENOVATION AND IMPROVEMENTS TO THE 900 WING
- (c) Section (a) of the Original Resolution is hereby replaced in its entirety by the following:
 - (a) That the Town of Farmington appropriate ONE HUNDRED FORTY-FIVE MILLION THREE HUNDRED THOUSAND DOLLARS (\$145,300,000) for costs related to the design, construction, furnishing and equipping of a new high school, substantially as described in the Farmington High School Schematic Design Report prepared by TSKP Studio, dated July 16, 2020, and as amended on January 11, 2021 and March 10, 2021. The project shall consist of (1) design, construction, furnishing and equipping of a new, three story high school building of approximately 239,000 square feet, to be constructed on the grounds of the existing Farmington High School campus, (2) demolition of substantially all of the existing Farmington High School other than the "900 Wing" and the "1928 Building", (3) renovation of the 900 Wing to house locker rooms and Farmington Public Schools Central Offices, and (4) related site work, including improvements to traffic patterns and vehicular circulation, additional parking, relocation of athletic fields, accessibility improvements to the upper fields, football field stands and press box and widening of Monteith Drive. The appropriation may be spent for design, construction, acquisition and installation costs, demolition and hazardous waste removal costs, equipment including but not limited to building systems and technology equipment, furnishings, materials, athletic fields, parking, sidewalks, lighting, utilities, landscaping, and other site improvements, architect's fees, engineering and other consultant fees, contract administration costs, grant application and administration costs, moving and relocation costs, legal fees, net interest on borrowings and other financing costs, and other expenses related to the project, including the preparation of schematic drawings and outline specifications for the project. The Town anticipates applying to the State of Connecticut for school building project grants to offset in part the cost of the project and anticipates that it will receive grants for the project in the estimated amount of approximately \$40,600,000. The Farmington High School Building Committee, or such other building committees for the project as are established from time to time, shall determine the particulars of the project and may reduce or modify the scope of the project including without limitation reductions and modifications appropriate in the event of a shortfall in anticipated project grant receipts to maintain the anticipated net municipal cost of the project, and the entire appropriation may be expended on the project as so reduced or modified.

- (d) In Section (b) of the Original Resolution, the amount of ONE HUNDRED THIRTY-FIVE MILLION SIX HUNDRED THOUSAND DOLLARS (\$135,600,000) is hereby deleted and the amount of ONE HUNDRED FORTY-FIVE MILLION THREE HUNDRED THOUSAND DOLLARS (\$145,300,000) is hereby inserted in its place.
- (e) In Section (c) of the Original Resolution, the amount of ONE HUNDRED THIRTY-FIVE MILLION SIX HUNDRED THOUSAND DOLLARS (\$135,600,000) is hereby deleted and the amount of ONE HUNDRED FORTY-FIVE MILLION THREE HUNDRED THOUSAND DOLLARS (\$145,300,000) is hereby inserted in its place.
- (f) Sections (f) through (i) of the Original Resolution are hereby ratified, confirmed, adopted and incorporated into this resolution.
 - (g) This resolution shall become effective after approval at referendum vote.

RESOLVED, that the resolution approved under item 1 above with respect to an additional \$9,700,000 appropriation and borrowing authorization for the Farmington High School project be submitted to a vote on Tabulators of the persons qualified to vote in town meetings on Thursday, December 8, 2022, between the hours of 6:00 a.m. and 8:00 p.m. Electors shall vote at their regularly assigned polling places, as follows: Electors residing in the First Voting District and assigned to polling places 1-1 and 1-2 shall vote at Irving A. Robbins Middle School, 20 Wolf Pit Road, Farmington, Connecticut; and those assigned to polling place1-3 and 1-4 shall vote at West Woods Upper Elementary School, 50 Judson Lane, Farmington, Connecticut. Electors residing in the Second Voting District and assigned to polling place 2-5 shall vote at the Farmington Police Department, 319 New Britain Avenue, Unionville, Connecticut; and those assigned to polling place 2-6 shall vote at the Community & Senior Center, 321 New Britain Avenue, Unionville, Connecticut; and those assigned to polling place 2-7 shall vote at the Municipal Complex, Monteith Drive, Farmington, Connecticut. Voters qualified to vote at town meetings who are not electors shall vote at their respective polling place at Irving A. Robbins Middle School, West Woods Upper Elementary School, the Police Department, the Community & Senior Center or the Municipal Complex. Absentee ballots will be available from the Town Clerk's office. Voters qualified to vote in town meetings will consider the following question:

"Shall the resolution entitled, 'RESOLUTION AMENDING THE RESOLUTION **ENTITLED** "\$135,600,000 **APPROPRIATION** AND **BORROWING** AUTHORIZATION FOR DESIGN AND CONSTRUCTION OF A NEW HIGH SCHOOL ON THE GROUNDS OF THE EXISTING HIGH SCHOOL CAMPUS, OF SUBSTANTIALLY ALL THE **EXISTING** DEMOLITION OF FARMINGTON HIGH SCHOOL OTHER THAN THE 900 WING AND THE 1928 BUILDING, AND RENOVATION AND IMPROVEMENTS TO THE 900 WING" TO INCREASE THE APPROPRIATION AND BORROWING AUTHORIZATION TO \$145,300,000,' which resolution appropriates an additional \$9,700,000 (thereby increasing the appropriation and bond authorization approved by the voters on June 3, 2021 to an aggregate \$145,300,000) for the design, construction, furnishing and equipping of a new high school, and authorizes the issuance of general obligation bonds and notes in the same amount to finance said appropriation, provided the amount of such bonds and notes shall be reduced by grants and other sources of funds received for the project (currently expected to be \$40,600,000), be approved?"

The ballot label for said question shall read as follows:

"SHALL THE TOWN OF FARMINGTON APPROPRIATE AN ADDITIONAL \$9,700,000 (INCREASING THE APPROPRIATION AND BORROWING AUTHORIZATION TO AN AGGREGATE \$145,300,000) FOR THE DESIGN AND CONSTRUCTION OF A NEW HIGH SCHOOL ON THE GROUNDS OF EXISTING HIGH SCHOOL CAMPUS, **DEMOLITION** SUBSTANTIALLY ALL OF THE EXISTING FARMINGTON HIGH SCHOOL OTHER THAN THE 900 WING AND THE 1928 BUILDING, AND RENOVATION AND IMPROVEMENTS TO THE 900 WING, AND AUTHORIZE THE ISSUANCE OF BONDS AND NOTES IN AN AMOUNT SUFFICIENT TO FINANCE THE PORTION OF THE APPROPRIATION NOT DEFRAYED FROM GRANTS (AN ANTICIPATED NET PROJECT COST TO THE TOWN OF \$104,700,000)?

To (Approve) (Reject) (Take No Action) on the Proposed Contract Between the Farmington Education Association (FEA) and the Board of Education.

NOTE:

This agreement was filed with the Town Clerk on October 20, 2022. In accordance with Section 10-153d of the Connecticut General Statutes, the agreement takes effect unless it is rejected by the Town Council at a regular or special meeting within 30 days of the date it was filed with the Town Clerk.

If the Town Council takes no action, the contract is deemed approved 30 days after it was filed with the Town Clerk.

If the Town Council rejects the contract, the parties shall commence the arbitration process, in accordance with the provisions of subsection (c) of Section 10-153f, on the fifth day next following the rejection which, for the purposes of the procedure, shall serve as the equivalent of the one hundred thirty-fifth day prior to the budget submission date, provided, if requested by either party, the parties shall mediate the contract dispute prior to the initial arbitration hearing.

Highlights of the Contract:

Term: Three-Year Contract Agreement (July 1, 2023-June 30, 2026)

Salary Changes:

- The agreement includes an equal dollar increase of \$1,200 for all steps until step 13 in years 1-3 (2023-2026).
- The agreement includes an increase of \$1,800 for teachers at the top step (14) of the salary schedule in years 1-3 (2023-2026).
- The agreement includes an elimination of step 2.
- Appendix B has been amended to show a projected increase of 3.69% (2023-2024), 3.72% (2024-2025) and 3.81% (2025-2026).

Insurance Changes:

- 2023-2024 premium cost share 22.5%; in-network out -of-pocket maximum \$2,750/\$5,500.
- 2024-2025 premium cost share 23%; in-network out -of-pocket maximum \$2,750/\$5,500.
- 2025-2026 premium cost share 23.5%; in-network out -of-pocket maximum \$2,750/\$5,500.
- The cap- that the Board contributes ninety percent (90%) of the cost of a Long-Term Disability Plan, has increased to \$5,000 per month (from \$2,000) or a maximum of 60% of the teacher's salary whichever is less.

- The term life insurance that teachers will be covered with has increased to \$50,000 (from \$30,000).
- Teachers will be notified thirty (30) days prior to open enrollment if such cash incentive will be offered for the succeeding school year.

Other Agreements:

- The contract adopted gender neutral language where binary descriptors previously existed.
- 2023-24- All stipends increase by 1.50%. Commencing March 1, 2023, the parties shall commence informal discussion over the restructuring and revision of Extra Pay for Extra Services and Stipends (Appendix C). Any changes through such informal discussion shall be made only by mutual agreement. On or after September 1, 2023, either party may initiate negotiations in accordance with Conn. Gen Sta. 10-153f(e) over the restructuring and revision of Extra Pay for Extra Services stipends (Appendix C) effective July 1, 2024.
- The Superintendent may permit teachers newly hired in Farmington to carry over up to fifteen (15) days of sick leave that they accumulated in another Connecticut school district, provided that employment in that other school district terminated no more than one hundred (100) calendar days prior to the commencement of employment in Farmington.
- Subject to mutual agreement and approval of the Association, teachers may be assigned to a work day schedule that starts before or after the teachers' work day for their assigned school, with a concomitant adjustment of the ending time of that teacher's work day. Such positions may also be posted by mutual agreement of the Board and the Association.
- Adjustments to language regarding voluntary and involuntary transfer procedures.
- Changes in language for teachers to receive tuition reimbursement and salary advancement.

The radios will be interoperable which will allow the user to communicate with police officers from other towns who use different frequencies. This purchase is part of a multiyear, planned replacement schedule of all portable radios in the Police Department.

The estimated value of the contract is \$58,188.50. Funds were included in the FY2022/2023 Capital Budget for this purpose. The contract award for the radios and accessories would be under State of Connecticut Master Contract A-99-001. This contract award is being submitted for Town Council approval because the contract value is expected to exceed \$50,000.

To award a contract for the installation of a card access security system at the Town's five fire stations to Security 101- Advance Security Integration LLC of Southington, CT at a cost of \$83,895.00.

NOTE:

This motion is to award a contract to Security 101-Advance Security Integration LLC to supply and install a card reader security access system at all of the Town's fire facilities. Security 101 will provide all equipment, installation, programming, testing, and staff training. This purchase is part of a multiyear, plan to upgrade the security at all Town buildings. Recently, Security 101 installed a similar system in the Town Hall building.

NOTE:

This motion is to contract with a vendor to purchase a 2022 Ford F-250 regular cab truck with a service body and snowplow package. The vehicle will be used by the Water Pollution Control Authority staff for pump station maintenance and snow plowing operations. It will replace an existing 2010 vehicle. Sufficient funds are available in the WPCA Rolling Stock account for this purchase.

The acquisition of this vehicle would be under State of Connecticut Contract # 19PSX0161. The pricing for the base truck (cab and chassis) is set by state contract. In addition, the contract calls for a 20% discount over the manufacturer's published prices for aftermarket options and accessories.

This contract award is being submitted for Town Council approval because the contract value exceeds \$50,000.

To award a contract for the purchase of one new 2023 Ford F-450 Truck with 3-yard dump body and snowplow package to Tasca Ford of Berlin, CT at a purchase price of \$88,380.40.

NOTE:

This motion is to contract with a vendor to purchase a 2023 Ford F-450 truck with a dump body and snowplow package. The vehicle will be used by the Highway and Grounds Division for road maintenance and snow plowing operations. It will replace an existing 2001 vehicle. Funds for this purchase were included in the FY2022/2023 Capital Improvement Budget.

The acquisition of this vehicle would be under State of Connecticut Contract # 19PSX0161. The pricing for the base truck (cab and chassis) is set by state contract. In addition, the contract calls for a 20% discount over the manufacturer's published prices for aftermarket options and accessories.

This contract award is being submitted for Town Council approval because the contract value exceeds \$50,000.

To Award Bid # 326, "South Road & Colt Highway Roundabout Project" to Morais Concrete Service, Inc. of Springfield, MA at a contract cost of \$2,511,634.00 subject to Connecticut Department of Transportation, CRCOG and CHRO review and approval.

NOTE:

The purpose of this motion is to award a contract to a qualified contractor to construct a roundabout at the intersection of South Road, Colt Highway and Two Mile Road. Bids for the project were opened on November 2, 2022. The Town received four (4) bids ranging from \$2,511,634.00 to \$2,859,826.50. Morais Concrete Service, Inc. submitted the lowest bid. They have previously performed work for the Town installing sidewalks. Staff has reviewed the paperwork and qualifications of the lowest bidder and have found them to be satisfactory.
