Report of the Town Manager

a. Police Reaccreditation:

The Farmington Police Department was reaccredited by CALEA (Commission for the Accreditation of Law Enforcement Agencies) on November 19, 2022.

The Farmington Police Department was initially accredited in 1992 and has maintained continuous accreditation since that time. The department voluntarily opens its operating procedures, general orders, and personnel protocols to external review to ensure the department is meeting internationally recognized standards and best practices in the profession.

The CALEA accreditation process now consists of a quadrennial review—with independent Compliance Service Members—inspecting accreditation standards during each year. Additionally, a Team Leader conducts an onsite review during year four. Our review involved thirty-one interviews. A formal accreditation report is then completed and reviewed by designated CALEA Commissioners. The process culminates in a hearing before the Commission's subcommittee prior to a final vote on reaccreditation.

Public Safety Management Specialist Amber Rush and Lieutenant Stephen Egan appeared before a CALEA subcommittee on November 19, 2022, to review the final report and answer any questions related thereto. The Subcommittee consisted of three CALEA Commissioner's and two CALEA Program Directors. The Farmington Police Department complied with 387 accreditation standards and was awarded reaccreditation.

In short, the Subcommittee was impressed with the department's dedication to professionalized law enforcement, its community policing efforts, its labor-management relationships, and finally its dedication to employee wellness.

b. 1928 Building Committee:

The 1928 Building Committee has been working with the project architect, Silver Petrucelli + Associates, through the design process for the renovation of the 1928 Building to accommodate Town Hall operations and multi-purpose recreational space. As part of the communication plan, the 1928 Building Committee is committed to providing timely updates to the Farmington community throughout the process. One vital piece of information that the committee would like clarity from the Town Council on is the fate of the 1928 Building if the referendum does not pass.

I am looking for Town Council consensus on what happens to the 1928 Building if the referendum does not pass. This information is necessary to assist the 1928 Building Committee with clear and complete communication.

c. Revaluation Update

The 2022 town-wide revaluation of all real estate in the Town of Farmington is complete. Residents should be receiving letters this week with their new property assessments. The new assessment reflects 70% of the fair market value of the property. The revaluation is required by law this year because it has been five years since the previous revaluation. Assessments derived from the revaluation will first be used for the July 1, 2023 tax bills.

If residents have questions on their assessed value or wish to review information used in the valuation of their property, they should schedule an informal hearing with the revaluation company, Tyler Technologies. At the scheduled informal hearing, appraisers will discuss market value and any corrections to assessment data on the property record card. The appraisals will not be able to discuss tax rates or estimated tax bills. Please note that all hearings will be conducted by phone.

To ratify the tentative collective bargaining agreement between the Town of Farmington and the Fraternal Order of Police, Lodge No. 331 for the period July 1, 2022 through June 30, 2025.

NOTE:

The Fraternal Order of Police, Lodge 331 and the Town of Farmington have reached a tentative collective bargaining agreement.

Highlights of the agreement include:

- Various language and procedural changes that have no net cost or effect but are favorable to the Town's needs.
- Updates to private police duty language. The Town is reimbursed for these services by a third party.
- The contract adopted gender neutral language where binary description previously existed.
- ➤ Health insurance changes including increased co-pays for office visits, prescription drugs, emergency room visits, allergy, and rehab services. Health insurance premium cost sharing increases for the PPO plan in 2023 and 2024.

Insurance: RX \$5 > \$10 \$25 > \$35 \$40 > \$50

Co Pays

- Specialist \$35.00 > \$45.00
- Office Visit \$25.00 > \$35.00

- ➤ For Fiscal Years 2023-2024 and 2024-2025 employees shall receive non-cumulative incentive pay equal to 1% of their base salary. This equates to \$46,411.99 for FY 2023-2024, and \$47,688.32 for FY 2024-2025. The incentive pay is for recruitment and retention. Due to recruitment difficulties in the police field over the past few years, this incentive pay is a creative way to both attract candidates and retain existing employees, without cumulatively increasing the cost of the contract.
- ➤ The cost of the three- year contract is a 10.27% increase, or an average of 3.42% each year.

This tentative agreement has been ratified by the union membership. Staff will be available to answer any questions.

To authorize the Town Manager to work with Farmington's Legislative Delegates to request that the State of Connecticut convey the Parsons Property to the Town of Farmington to use as Modified Open Space at a minimal fee to the Town.

NOTE:

As you are aware, Parsons Property is an important gateway into Farmington. The Town has been looking to acquire this piece of property from the State of Connecticut since 2015.

On September 13, 2022, the Town Council reviewed the history and status of the Parsons Property. Below is a brief summary of what was discussed at the September meeting.

Summary:

Between 2015 and 2020, it was the intent of the Town to purchase the Parsons Property for Economic Development purposes. Over time, the Town Council realized that between the substantial purchase price of the property from the State of Connecticut, the environmental factors that needed to be addressed, and the changing market conditions, developing the property for economic development purposes was no longer achievable or practical.

In March of 2021, the Town Council determined that the correct use of the property was modified open space. The State of Connecticut Department of Transportation agreed to convey the property to the Town for \$1,000 for modified open space. This includes such uses as a Welcome Gateway into the Historic Village Center, increased public parking, with access to the planned Historical Society Welcome Center, and the potential for the relocation of a historic structure. It should be noted that this agreement did not preclude the Town from renegotiating a new value with the State of Connecticut if the Town determined the property would be used for economic development in the future. The Town was informed that this conveyance would be an internal transfer process through the CTDOT, not a legislative process.

In July of 2022, the Town was made aware that the CTDOT was not permitted to convey the Parsons Property to the Town through an internal transfer process and advised the Town to go through the legislative process.

By approving this motion, the Town Council is reaffirming the previous policy decision regarding the development of this property. The Town Council is also authorizing me to work with Farmington's Legislative Delegates to convey the Parsons Property to the Town of Farmington through the legislative process, to use as Modified Open Space at a minimal fee to the Town.

If the Town Council chooses not to move forward with this motion, there are two alternative options to consider.

Alternative Options:

Option 1: The State Selling the Property to the Town of Farmington for Economic Development

The first alternative would be to purchase the property from the State of Connecticut for the average of two appraisals plus an administrative fee. In 2019, the State conducted two appraisals of the property and determined the average value was \$2,010,000.

Option 2: The State Selling the Property to a Private Developer for Economic Development

The second alternative is to not pursue the property. In that case, the State of Connecticut would market the property to a developer. If a developer purchases the property, the Town's only involvement would be through Plan & Zoning.

To award a contract in the amount of \$68,200 for the acquisition and installation of communication equipment to convert the West Farms Mall Site into a simulcast transmit site for public safety communications to NORCOMMCT of Naugatuck, CT.

NOTE:

The purpose of this motion is to contract with NORCOMMCT of Naugatuck, CT to provide the equipment and labor necessary to convert the West Farms Mall radio receive site into a simulcast transmit site for public safety communications. The Town utilizes the roof at the West Farms Mall for stationing radio equipment for public safety communications at the mall and the surrounding area. Over the years the radio coverage in this area of Town has experience deterioration causing communication problems. Town staff have researched the coverage problems and have determined that converting the site into a simulcast transmit site would improve coverage.

Funds were included in the FY2022/2023 Capital Budget for this purpose. The contract award for the equipment and labor would be under State of Connecticut Contract # 19PSX0088. This contract award is being submitted for Town Council approval because the contract value is expected to equal or exceed \$50,000.

Town staff will be available at the Council meeting to answer any questions.

To Set the Registrar of Voter's Salary for Fiscal-Years 2023 and 2024.

NOTE:

The Registrar of Voter's Salary is set at the beginning of each new term by the Town Council. The current salary for our Registrar of Voters is \$29,400 per year. A recent salary surveys shows that this salary is in line with surrounding and similar towns.

The incoming Registrar of Voters are brand new to the position, but not to Farmington elections. Both have experience working the polls on Election Day. Although the position is part-time, the Registrars ultimately bear the responsibility of running the elections. They also maintain and manage an extensive number of part-time and temporary workers.

It is my recommendation that, at this time, the Town Council continue to set the incoming Registrars salary at the rate of \$29,400 per year. It is anticipated that the State Legislature will finalize the details for Early Voting in the near future. Once we understand the additional workload, I recommend that the Town Council reexamines the salary to see if it is still appropriate.
