Description of Change Order: This Proposal includes the installation of shot put, discus, and Javelin throwing facilities within and adjacent to the existing upper athletic fields north of the new high school building currently under construction. The scope of work includes the clearing and grubbing of areas to be regraded, preparation of subgrade, fabrication and installation of Track and Field throwing event facilities, removal and capping a portion of existing irrigation system, installation of stone dust pavement, and placement of topsoil, seed and other restoration work as needed.
