### **Public Hearing**

1774 Farmington Avenue – Matthew & Chalise Ross – Removal of one chimney, replacement of two doors with windows to match existing and replacement of one window and removal of one window on the side of the home.

(Matthew Ross Recused) Matthew Ross presented the application. Matthew is looking to renovate the existing kitchen and small dining room into one larger kitchen. As part of this project, he is proposing to remove one of the three chimneys which currently run through the center of the dividing wall, remove the window above the existing kitchen sink along the side of the house. He is also looking to replace two of the side doors facing Farmington Avenue with windows that match the existing windows. The remaining window on the side of the home will be replaced to match the existing windows. Matthew Ross showed photos of the home from multiple angles, to display that the removal of the chimney will not be noticeable from most viewing angles from Farmington Avenue. The new windows will be Anderson 400 series Fibrex windows, and the trim will be wood or wood composite to replace the existing aluminum trim.

Matthew Ross also provided some information regarding the history of the home, from its original construction, to a conversion to a two family, and back to a single family home, and the additions that have been made through the years.
