During the permitting phase of the project, a question came up regarding the location of the septic system. Although the homeowners thought they were connected to the sanitary sewer system, after further investigation it was discovered the house was still connected to a septic system. They are now seeking a modification of the prior approval to install a sanitary sewer line so that the house can be connected to the sanitary sewer system. The existing septic tank will be abandoned per code requirements. Mr. Quisenberry stated there is a large tree in the front yard they will do their best to preserve if at all possible.

VOTED: To approve the modification to prior approval to install sanitary sewer line for property located at 1651 Farmington Avenue with the condition that they preserve the large tree in the front yard if possible.
