Upon a motion made and seconded (Ku/Guerrera) it was unanimously VOTED: to adjourn at 4:54 P.M.

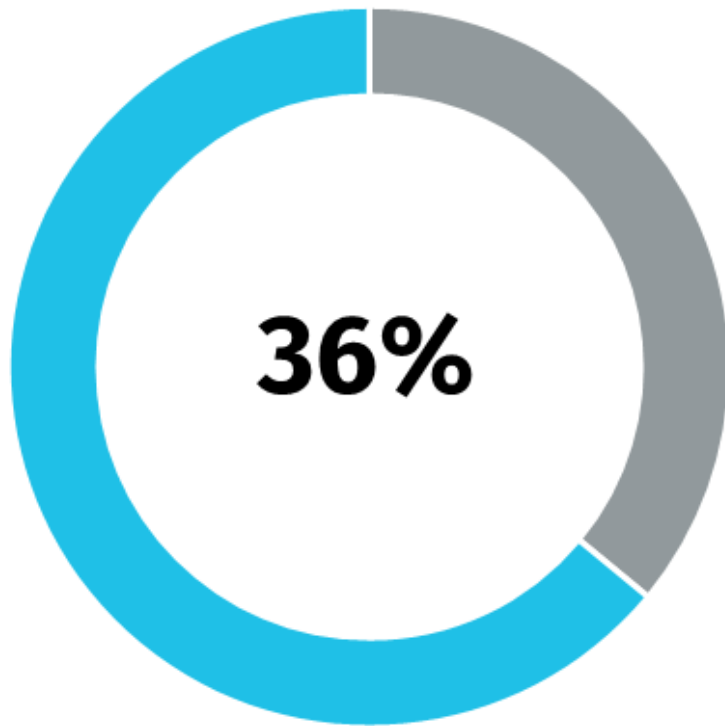

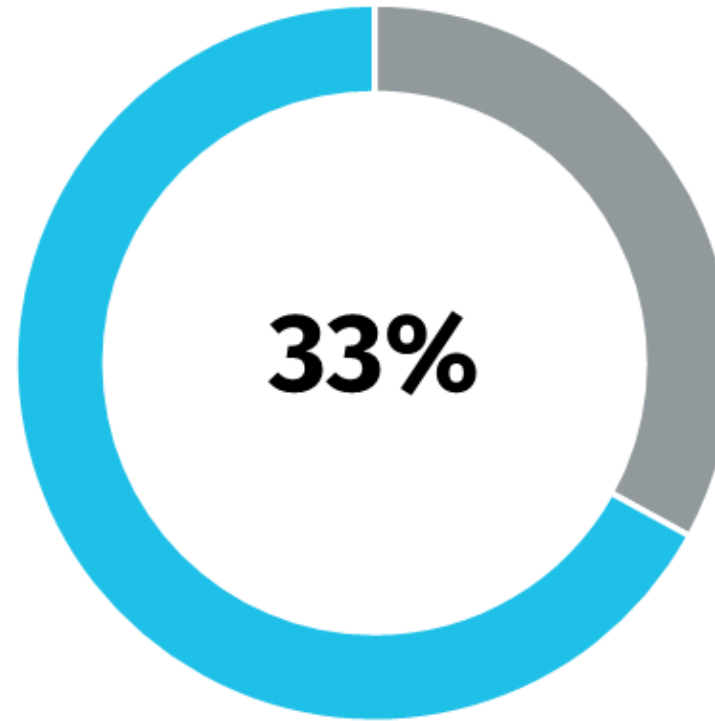


Building Construction
