4) 1928 Building Committee Liaison Report.

Chris Fagan reported that the 1928 Building Committee met last night and reviewed the Construction Documents and subsequent third-party cost estimate. The sitework package will be released in June for bidding, and the general construction package will be released in July for bidding.

Archana Pai reported that TSKP Studio continues to work with the professional team on RFIs and field reports. Other topics that TSKP Studio is working on is Room ID and signage, as well as halls, frames, doors for the 900 wing.

6) Construction Manager Report.

Nelson Reis reported that there were three bidders on the tennis court bid package, and that O&G is scoping two of the bids. O&G Builds is currently done for the season but will start up again after abatement is completed. More drone footage will be shot in July.

7) Project Management/Contingency Report.

Russ Arnold reported that the contingency for the project remains strong. \$220,000 in pre-detailing for steel has been added to the contingency log. Russ reported that we are still awaiting pricing for the potential expansion of the bleachers and that this would be eligible for 15% reimbursement.

8) Owner's Representative/Move Manager Report.

Chris Mitchell reported that he is confident that the project will meet O&G's schedule. Arcadis is preparing move management and will hit the ground running on June 12th. The first furniture delivery is expected on June 19th.

9) Communications Subcommittee Report.

Meg Guerrera reported that the Communication Subcommittee met earlier today to discuss the Ribbon Cutting Ceremony which is tentatively planned for August 26th (the evening before the first day of

school). An additional open house will likely take place in October as well. A postcard will be sent out soon notifying residents that the high school campus will be offline during the summer while construction activities occur.
