FARMINGTON HISTORIC DISTRICT COMMISSION REGULAR MEETING

PUBLIC HEARING

Renewal by Andersen of Southern New England – 96 Main Street

Commissioners voting on this matter were Bombara, Calciano, Gemski, Lawson, Phelan.

Temporary Certificate of Appropriateness to replace windows at 96 Main Street. Continued from the May 21, 2024 meeting. David McLellan, Renewal by Andersen of Southern New England, had provided some addresses where the same composite windows were installed for the Commissioners to view as requested at the last meeting. The applicant confirmed the existing windows have no grid pattern and that they are proposing to replace the existing windows with fiberex composite windows, also with no grid pattern. The exterior trim will remain. Mr. McLellan had also provided details on the process of removing the existing windows and sash weights, insulating the sash cavity and inserting the replacement window at the last meeting and confirmed the existing window frame will not change.

There was no public comment in favor or in opposition to the application.

The public hearing closed at 5:07 p.m.

VOTED: To approve the Renewal by Andersen of Southern New England application for Temporary Certificate of Appropriateness to replace windows at 96 Main Street as presented and on file in the Planning Office.

Bianca Signs Plus LLC – 771 Farmington Avenue

Temporary Certificate of Appropriateness to replace sign at 771 Farmington Avenue. The representative was present online and after experiencing technical difficulties was tabled for the next application to be heard.

Miss Porter's School – 60 Main Street

Temporary Certificate of Appropriateness to replace cupola railings at 60 Main Street. Jackie Murray, Miss Porter's School, appeared in person to present photos of the condition of the top wood railings on the cupola. She also provided the material detail sheets describing the proposed replacement components explaining the composite material is used elsewhere on campus. The replacement railings will be exactly the same height and width as the existing railings. Ms. Murray also stated the style will be very similar to existing. The Commissioners asked clarifying questions, which Ms. Murray responded to.

There was no public comment in favor or in opposition to the application.
