Minutes of the Town of Farmington Regular Town Council Meeting January 10, 2017

A. Call to Order

The Chair called the meeting to order at 7:00 p.m.

B. Pledge of Allegiance

The Council and members of the public recited the Pledge of Allegiance.

C. Presentations and Recognitions

1. Streetlight Purchase and Conversion to LED Lights – Assistant Town Planner, Shannon Rutherford and Director of Public Works, Russ Arnold

Ms. Rutherford, Assistant Planner explained to the Council the reasoning behind purchasing from Eversource and the conversion to LED of the Town's street lights and answered Council questions. She had been researching this process since the summer. The maintenance issues were the stumbling block in the past and this issue had now been resolved by the development of private sector companies doing street light maintenance contracts. She noted the Town of Farmington had just over 1700 street lights and the budget line to maintain and for energy costs to Eversource was \$250,000 a year. She outlined the financial basis for purchase using the hand out recorded with these minutes as Agenda Item C-1. She explained the analysis she had done showed little price difference between the private companies handling the maintenance of the lights, but the internal processes of Tanco Lighting was best suited to the Town of Farmington's needs. It was the consensus of the Council to have an action item on the agenda of the first February Town Council meeting to authorize the Town Manager to sign a contract with Tanco Lighting Corporation to begin the process to analyze the exact costs of conversion to town owned street lights.





Conceptual Plan 01/04/2017






OPTION D - THIRD LEVEL

The Governor also cut each Towns' FY2016/2017 LOCIP allocation. These funds are usually made available to municipalities in March. The Town of Farmington's grant reduction equaled \$137,501. The Town does not include the LOCIP grant in the operating budget. Rather these funds are used in future years to fund projects in the Capital Improvement Budget. The reduction therefore means that less funding will be available for Capital Projects in the FY2017/2018 budget.

^{**} On December 29, 2016 the Governor announced mid-year budget reductions to education grants and to the LOCIP program. The amount shown is the estimate of what the Town will receive for the ECS grant based upon the reduction.
