### A. Call to Order.

The chair called the meeting to order at 4:31 p.m.

### B. Public Comment.

Pam Fisher, 5 Julles Court, Unionville, informed the committee that looking at the big picture is the right decision. She spoke in opposition to "Option A" and does not believe it addresses all the facility issues. She spoke in favor of "Option D" as it addresses the issues more efficiently and provides a 50 year solution.

Beth Kintner, 24 Farmstead Lane, expressed that she believes the changes made to Options "A" and "D" are less than desirable for a long term solution. She believes the original "Option D" had the potential to benefit the community as a whole; however reductions/eliminations including the black box theater, size of gym, culinary program and the 4<sup>th</sup> field lead her to believe the committee is moving away from the best solution. She suggested that the committee keep the original "Option D" on the table and provide tax implications for each of the options so that the committee and the public all have the opportunity to thoroughly review each of the options. She understands that a long term comprehensive solution is expensive, but believes that a less than ideal design may cause a lack of support for the project as a whole.

Vince Cunningham, 63 Oakridge Drive, expressed the need for a long term solution. He would like the committee to "do it once and do it right." He is in opposition to "Option A" and if this option was presented to him at referendum, he would not vote for it.

Emily Kaliney, 30 High Street, has been following the building committee's process and is disappointed with the new options. She urged the building committee to trust the community and emphasized the importance of providing a better choice than a "scaled back" option "A" and "D."

Olivia Germano, 25 Firenzi Lane, expressed that the committee needs to spend the money for the best option. She suggested the committee survey the community to get feedback on which option they prefer.

Chelle Grande, 6 Ashford Court, informed the committee that she would not vote for "Option A." She urged the committee to consider the importance of athletic facilities and drama/music productions during construction, as home games/productions produce revenue for booster clubs. She believes that a reduction of field/gym space is not beneficial or acceptable. She urged the committee to spend the money to produce a facility that will last a long time.

Upon a motion made and seconded (Kleinman/Donald) it was unanimously VOTED: to approve the January 25, 2017 minutes.

### D. Various Communications and Written Appeals

The committee received comments and opinions via email and through the project website. Additional correspondence was added, as it had been received after agendas were distributed on February 3, 2017. A copy of the correspondence is recorded with these minutes as Agenda Item D.

### E. Reports/Updates.

Chairman Wadsworth informed the committee that the subcommittee update would be given prior to the architect's report.

### 1) Subcommittee Update on Options "A" and "D"

The subcommittee met on January 27, 2017 and February 3, 2017. The subcommittee was charged with reducing the size and cost of Options A and D. Kaestle Boos and school administration met in addition to the subcommittee meetings to determine where changes could be made. The revised options, as a result of the subcommittee meeting, will be presented by Kaestle Boos.

### 2) Architect Report (Dominov)

Minutes are considered "DRAFT" until approved at next meeting

Paul Dominov, Kaestle Boos Associates, presented the two conceptual options to the committee. A copy of the presentation is recorded with these minutes as Agenda Item E-2.

### Highlights of revised "Option A":

- 236,339 sq. ft. (school only) + 9,626 sq. ft. (BOE)
- Expand cafeteria
- · Move kitchen to the back of the building
- Demolish the 500,600 and 700 wings
- Move Board of Education to the 2<sup>nd</sup> floor of the 2003 building
- Small addition by auditorium for woodshop/auto classrooms

### Highlights of revised "Option D":

- 239,046 sq. ft. (school only) + 9,626 sq. ft. (BOE)
- Eliminate Square Footage- Alternative High School, Culinary, Black Box Theater, Amphitheater in Learning Commons, Café in Learning Commons, Collaborative space in clusters
- Reduced Square Footage- Large Gymnasium, most spaces throughout the building by approximately 5%, storage spaces
- Other Items: Three fields on the hill, not four, Wood and Auto Classroom eliminated with Larger Lab spaces for both
- Two Scenarios- BOE in school building (3<sup>rd</sup> floor above guidance) or in 1928 Building

The committee had general discussion on the changes made to Options "A" and "D" as summarized below:

- Options for 1928 building if Board of Education is located in the school
- · Disappointed that there is no culinary program
- Removal of black box theater- Paul Dominov informed the committee
  that he spoke with the auditorium consultant and the black box theater
  would only be used for drama and the auditorium for music. If the
  black box theater is removed, the auditorium would be designed to
  accommodate both.
- Extra space for students to have "quiet study time"
- It was recommended to evaluate the feasibility "flipping the design" and moving it over on the parking lot- the main entrance would be on the side the auditorium is now.

Chairman Wadsworth stated that the subcommittee feels that they met their charge of reducing the size of the building.

Upon a motion made and seconded (Kleinman/Baron) it was VOTED: to provide cost estimates for the revised "Option A" (renovation) and "Option D" (new building). In addition, evaluate the various options for where to place the Board of Education to provide a standalone price for central office, evaluate the feasibility of a 4th field, mothball 1928 building, and provide pricing for the addition of a culinary program.

The original pricing from the original "A" and "D" will be provided to compare the options.

Message FHS Building Committee: Thank you all for your continued commitment to the future of Farmington. I have 2 questions and I comment to share that I hope you will consider. Questions (and apologies ahead of time if these were already addressed, as I had to leave last night's meeting at ~6pm): 1. At yesterday's meeting (Jan 25, 2017), the Town Manager stated her tax increase estimates was based on a total project price-tag of \$162M, "the biggest number I saw." ... My first reaction is that this does not consider reimbursement from the State, where the largest possible number that Farmington would be responsible for is in the \$137M range (if my notes are accurate). Is this a valid discrepancy to note, and if so would using the lower number make a material difference to lowering the tax increase estimates? 2. Also at yesterday's meeting it was noted several times (after the disheartening tax estimates) that the numbers were too big to swallow. So to me the natural question that follows is: what numbers would be more palatable? What are the limits where "that's acceptable" becomes "that's too much"? ... And those limits become the place from which to move forward. There is no need to respond to me on any of this; I just believe these are important considerations to move the committee forward. And for whatever my \$0.02 is worth: with Ms. Greider and her team in place to lead the way, the estimated tax increases for Option D would be worth every penny in my humble opinion. (But I also agree that chances of such a budget passing Town Council/referendum would probably be slim at best). Lastly, a comment on what should probably be an afterthought to all of this (again, appreciate your consideration and no need to respond): The architects have asserted that there is room for 4 athletic fields on the top level, rather than the current 3. In such a case it is imperative to include a netting system around the perimeter of those fields as part of the budget. Currently

- Message Good Afternoon, Thank you for all your time and effort that you have put into this very important project. My son will be attending the High School in a year and a half. Although he will probably not see the final renovations upon his graduation, it will certainly impact his time there in the school and for all the future classes of Farmington. After reviewing all of the plans previously we definitely liked the layout of Option D best. I see from my recent email that this has been modified quite a bit due to the cost factor. It is certainly understandable but we need to keep in mind the long term needs of the students and the future generations. I feel we would be short changing our children if we cut comers now during this process. Projecting lower enrollment is not a valid enough reason to make a school smaller. When West Woods Upper Elementary School was built, it had more than ample space in the school so it could accommodate a growth in the town. There will be ups and downs in enrollment over time which will be unforeseen and not easily predictable. My son is a musician as well as myself and we understand the importance of having the proper space to perform and practice. We feel that the auditorium should absolutely be kept as in the original plans (which I believe it is) but to not eliminate the practice rooms or the black box theater. I remember in one of the recent meetings two high school girls expressing their concern about this. It would be a very versatile room and is necessary for students to have this outlet of expression. I believe that keeping the collaboration space in each cluster makes more sense then just adding it to the learning commons. This would be utilized immensely and create a better and more relaxed and inviting learning environment for each grade. If the "cafe" area of the library is being eliminated will there be ample space for the students currently? Will the space be enlarged from the original space? Will the new cafeteria area be large enough to






