A. Call to Order.

The Chair called the meeting to order at 4:31 p.m.

B. Public Comment.

Joanne Fishman, 145 Oakridge Drive, Unionville, stated that she wanted to follow up on her request for a comparison list of the option to compare and contrast the choices. She said that she is very disappointed to see that the collaboration space in the clusters would be compromised. She expressed the need for quiet space for students to complete their work and/or collaborate with one another. She also expressed disappointment in the removal of the culinary program and black box theater. She believes that taxpayers aren't afraid to pay more for this project in order to preserve the reputation and quality of life in Farmington.

Tom Lyons, 30 Dorset Lane, thanked the committee for their work on this project. He expressed concern regarding the expense associated with this, citing the project's anticipated tax increase and Governor's proposed budget. He questioned how this project morphed into over a \$100 million project for a new school. He expressed that building a new school does not make sense and he believes there are other solutions to consider. He asked the committee to consider the financial impact of this project on all residents.

Ned Statchen, 6 Belia Lane, Unionville, asked the committee to reconsider cutting 30,000 square feet from the building. He doesn't want the cost to dictate what should be provided in order to provide the best school for the children.

Sarah Huelin, 21 Bidwell Square, commented on what the draw of a new school will do for the Town of Farmington. She informed the committee that she is a teacher, but would not take a job here due to the facility. She firmly believes that if this school does not undergo massive physical changes to allow for educational and community use, we will lose the quality of education, the educators that choose to work at the high school, and that property values will decrease.

Pam Fisher, 5 Julies Court, Unionville, expressed concern that the building limits the educational programming that is provided. She commented on the NEASC warning and believes we it is critical to invest in the future. She also is concerned that people in the community do not know about the project and the project's history.

Jillian Ciriello, 4 Glenmore Drive, informed the committee that she moved to Farmington approximately 6 months ago and the educational system was what drew her to Farmington. She had the opportunity to tour the facility and was surprised at the condition of the school, the limited resources the teachers have to work with and the size of the auditorium. She urges the committee to avoid another band aid approach.

Marc Sklenka, Colliers International, provided the committee with an Owner's Project Manager Report and reviewed the contents of the report. A copy of this report is recorded with these minutes as Agenda Item E-2.

3) Construction Manager Report (Biega) No Report.

4) Financial Report (Eagen)

Town Manager Kathy Eagen provided the committee with a financial update and reported that the expenses to date are 77,900.94. A copy of the financial report is recorded with these minutes as Agenda Item E-4.

F. To approve the attached invoice from Colliers International in the amount of \$8,136.

Upon a motion made and seconded (Carrier/Bernier) it was unanimously VOTED: to approve the invoice from Colliers International in the amount of \$8,136.

G. To approve the attached invoice from GNCB Consulting Engineers, P.C. in the amount of \$4,900.00.

Upon a motion made and seconded (Carrier/Baron) it was unanimously VOTED: to approve the invoice from GNCB Consulting Engineers in the amount of \$4,900.

H. To review and consider conceptual options for the FHS Building Project.

Marc Sklenka, Colliers International presented conceptual designs, project schedule, phasing options and project budget ranges for Options "A1" and "D1." A copy of the presentation is recorded with these minutes as Agenda Item H-1.

Kathy Eagen, Town Manager, presented the Farmington Tax Impact for the average residential assessment of \$232,074 for Options "A1" and "D1". A copy of this presentation is recorded with these minutes as Agenda Item H-2.

The committee had general discussion regarding Option A1. Justin Bernier presented his ideas for opportunities to use more of the existing building that include not adding a second floor on the 2003 building, reduce the number of floors and renovate more of the existing building, and leave/repurpose the 500 wing. Tim Harris explained that plumbing issues exist in the 500 wing, and previous work has been done in certain areas to fix the immediate problems, but believes similar problems may arise in the future.

When asked what a \$75- \$80 million dollar renovation would look like, Marc Sklenka, Colliers International, explained that the consultants reviewed a \$75 million option and because of the size of the building, construction cost is approximately \$200 per square foot. Bruce Gelbar, O&G Industries, Inc. informed the committee that this size renovation will not allow for additions, and would only include HVAC, new ceilings, new floors, painting, fire

protection, ADA and some plumbing. This project is square foot driven due to the size of the existing building.

The committee had general discussion regarding Option D1. Justin Bernier questioned if "quiet space" was added to D1. Superintendent Kathy Greider explained that there will be quiet space in the clusters as well as the learning commons. She also commented that the learning commons will be a combination of collaborative space, quiet space, flexible space, and will have all options for all learners. D1 is a flexible, 21st century school building that is designed for student centered teaching and learning. Bill Silva, FHS Principal, commented that the learning commons has not yet been designed, but collaborative, quiet, and flexible space will be included in the design.

I. To instruct Kaestle Boos Associates and O&G Industries, Inc. to begin schematic design drawings and cost estimating for Option_____.

Johnny Carrier supports option D1 and doesn't see the advantage of spending \$10 million less for a renovation option over a new school. He trusts the consultants when they say a \$75 million dollar option does not exist to meet the committee's charge. He is confident making the motion to begin schematic design and believes D1 is the best option for Farmington.

Jean Baron seconded the motion and reminded the committee that they are charged with a 50 year option. This committee's job is to keep the project cost down and she believes it is attainable with this Option D1. She noted that there have been significant changes in the educational opportunities and the building itself in the past thirty plus years. She is, however, concerned with the lack of collaborative space. Superintendent Greider stated that her number one priority is to capture back collaborative space as they go through the schematic design process, as it is an important feature to the design. Paul Dominov believes that the building is flexible enough to recover some of the collaborate space that was removed.

Dan Kleinman has a long history with Farmington Public Schools and the delivery of education has changed dramatically. He believes a comprehensive approach is necessary instead of another band aid solution. He believes a new high school is the best long term approach for Farmington and that the current facilities are not commensurate with the quality of education provided in Farmington.

Justin Bernier requested that the committee meet again on March 8th to closely evaluate a renovation option and cost over the next week. He believes we are destroying facilities that do not need to be destroyed and that there is another solution to keep more of the existing building.

After continued discussion, Dan Kleinman requested that the Chairman call the question on the table. It was VOTED: to call the question.

Minutes are considered "DRAFT" until approved at next meeting.

Adopted.

Voting yes were Wadsworth, Carrier, Baron, Kleinman, and Hamilton. Voting no was Bernier.

Upon motion made and seconded (Carrier/Baron) to instruct Kaestle Boos Associates and O&G Industries, Inc. to begin schematic design drawings and cost estimating Option D1.

Adopted.

Voting yes were Wadsworth, Carrier, Baron, Kleinman, and Hamilton. Voting no was Bernier.

J. Other Business.

Chairman Wadsworth reviewed the upcoming schedule with the Committee and indicated that the March 8, 2017 meeting will be cancelled. The committee will meet again on March 22, 2017 to review the schematic design process. A Schematic Design subcommittee will be established to review progress and report to the committee.

Kathy Greider commented that the proposed referendum date currently falls on the same day as graduation. Kathy Greider and Kathy Eagen will work together to determine any necessary schedule changes.

Chairman Wadsworth indicated that updates should be provided to the Board of Education and Town Council through the liaisons and the committee is happy to meet with either the Board of Education or Town Council if requested.

K. Adjournment.

Upon a motion made and seconded (Carrier/Hamilton) the meeting adjourned at 6:48 p.m.

Please accept this long public comment, in writing. I will attend today's meeting and make a short statement at 4:30.

Collaboration Space for all classrooms - not just in one place in the building to be grabbed by 1200 students and faculty - is essential to prepare our students for the sophisticated environments that will enter either in colleges or workplaces. As a former HR Manager/Employment Recruiter - these skills differentiate candidates 15 years ago and as a small business owner I see an absence of it many times now.

Also, during 8th Grade Parents Night I saw the space the teachers have to meet with students - they deserve better. You are recruiting and retaining some of the best talent in educators.

Culinary Program my oldest son Class of '10 was the last. It brought the best out in an inconsistent student, "jock" who could be self-centered at times - the hands-on small group approach gave him confidence and pleasure. He was also grateful for the teacher's insight and support of him.

Every where I see demand for culinary arts training for entry level employment and career opportunities which many which do require advanced technical education but a high school culinary program can help prepare students for a variety of careers in wellness, nutrition, business management and event sales not just cooking or chefs. Found a quote from another CT school "It's much easier and much less costly if they learn this [true interest or not] in high school rather than after studying it in college."

As a parent of 4 with 2 already over 22, we can't assume all FHS students will be successful/thrive or enjoy college - and many need to earn an income for their education. Our own students are challenged to find employment in their own town. If not just for the "Joy of Cooking" and a hands-on occupation that delivers satisfaction.

Black Box as a proud parent of 3 theater performers I see the benefits to self development, collaboration, imagination. The public enjoys this and it should be an asset for the tax payer! I believe many would volunteer to coordinate MORE access for seniors AND families to pay for a variety of programs presented by visiting performing, cultural enrichment artists.

Plus, we can parlay this facility and skills into a self-sustaining entity, if we choose to provide a public option for catering. This is an ideal "alt ed" experience as well - these models already exist. Exhibit the character traits we attempt to build in students: creative problem solving and tenacity. "Effort = Success"

I understand that there are Board of Ed members who are also disappointed so I ask my elected officials to maintain your position not to decrease this space because once it's not built our town can't add it. This impacts the decades ahead of us that we set out to improve - remember this isn't a Band-Aid, this is foundation for the next 30-50 years.

The Gymnasium is a "no brainer" - we need the space! Add up what we pay to rent elsewhere - are costs passed onto parents for programs managed by Parks & Recs in the same town?

Don't be afraid to let the voters choose what they want! You set out to be inclusive, gain support as well as input - it's required in a democratic society. Our mill rate is very low but to maintain the quality of life Farmington wants we can't get it for nothing. Do not eliminate Option D, please calculate the true cost/benefit analysis and implications for all options for the public to learn; remember they told you what they wanted beginning in September.

Your awareness, involvement, and participation are crucial right nowl

Here's where we stand with the high school renovation project:

The subcommittee has been working on scaling back both Option A (a minimal renovation that leaves much of the exiting building) and Option D (an extensive renovation that is about 90% new construction) since January 27th. At their last meeting last Friday, the subcommittee discussed what progress had been made in the re-design for Options A & D.

Now, keep in mind that most of the feedback we have heard from parents and other residents over the past several months on numerous occasions (the community visioning session in September, at the community meeting in December, during public comment at Building Committee meetings, in correspondence to the Building Committee, and in personal discussions) is that they absolutely want the high school facility improvements to include as much new construction as possible, to be a resource for the entire community; that it should be a long-term solution, and the changes should be comprehensive, not a short-term fix. People have expressed the importance of the building being wellsuited for 21st century learning, whatever that may look like years from now; that it be constructed in such a way that it will remain flexible enough to be adapted to the inevitable changes in expectations and needs over the coming years. And yet, unfortunately, the Building Committee seems to be moving away from a comprehensive design. There is concern on their part that the most expensive option (Option D) would raise taxes too high and put the town's debt ratio at or near 16% when the recommended ratio is 10% or lower.

At TODAY'S Building Committee meeting (2/8), the subcommittee will present their revised, scaled-back designs that came from Options A & D. Our last update listed what was eliminated or changed in the revisions both options, although we do not consider either version of Option A a suitable design. I want to emphasize that it is unlikely that any of those features would get added back in once they've been eliminated. Our goal at this point should be to express our concerns with moving forward with only scaled-back designs. Here's what you can do to give your feedback in response to the elimination of space & features in Option D:


- 1. Plan to attend the Building Committee meeting TODAY, Wednesday, 2/8 at 4:30pm (Farmington High School library).
- 2. Write a short email to the Building Committee (http://wwwfhsbuildingproject.org/contact):
 - express your concern regarding the elimination of key elements in the design. Choose one or two that are most important to you: overall space reduction of 5%, space for the culinary program, collaboration spaces in the classroomwing, black box theater, & reduction in size of the gymnasium. Also good to note: many of these features were priorities for members of the community at-large.
 - ask that the committee does NOT take the original Option D off the table. It should be considered alongside the scaled-back options. When the price ranges are determined for the new scaledback options, tax implications should be presented for ALL THREE options for a fair comparison and a true cost/benefit analysis.
 - emails can be from an individual or from more than one Individual. Be sure to include everyone's full name & address.
- 3. Make public comment at the Building Committee meeting you may read your email if you'd like, summarize your main points, or bring up different points. Public comment is one of the very first agenda items, so be sure to be on time!

Your participation can have a big effect on what finally gets built as our "new" high school in town, and it will have implications for many decades of learning at Farmington High School!

Please take a few minutes to at least send an email to the Building Committee. Your voice should be heard. Being in the audience for these public meetings is impactful, but speaking directly to the committee members at public comment is even more so (and it's not as bad as you might think). I hope to see a good number of you at the meeting!

I understand there are many stakeholders in this project and greatly appreciate your work to create the best High School for our children while also taking budgetary restrictions into consideration and planning for the future needs of all Farmington residents. I have extreme reservations regarding the revised option A plan primarily because is does not include the cluster classroom design. Dear Kathy:

Thanks for the presentation you put together showing the tax impact of the initial \$162 million price tag. It was a bit sobering!

I have one suggestion for the next round, which you have probably already thought of, but just in case thought I'd send along. This is going to be painful no matter what, so I was thinking about the decision makers, as well as the average tax payer, and their thought processes.

Would you be able to do a side by side comparison of the key items for each of the revised A and revised D plans high range of the estimates, and then the difference between the two? As well as show the cost to average home value of each of the options we asked them to quote? I think it would be helpful in the decision making to see the difference to each household of the two options, one that may be more of a band-aid addressing the immediate needs, and the other which will hopefully serve us longer term. Then it might be easier to do a cost benefit analysis between the two. Something like the following:
